

Disputing the 1099G

If a claimant disagrees with the amount shown as benefits received during the calendar year, they should be instructed to submit a dispute request through their Claimant Homepage.

The claimant will click the “Dispute my 1099G” smart link which will bring up a new window with the 1099G Dispute screen.




